

CASIA HFB DATABASE RELEASE AGREEMENT

Introduction

CASIA heterogeneous face biometrics (HFB) database is used for scientific research of heterogeneous face recognition. It is collected by Institute of Automation, Chinese Academy of Sciences (CASIA). Any one or group is allowed to use this database free of charge.

Rules

1. **Redistribution:** Without prior approval from CASIA, CASIA HFB Database, either entirely or partly, should not be further distributed, published, copied, or disseminated in any way or form, no matter for profitable use or not, including further distribution to a different department or organization in the same system.
2. **Modification:** Without prior approval from CASIA, CASIA HFB Database, either entirely or partly, is not allowed to be modified.
3. **Commercial Use:** Without prior approval from CASIA, CASIA HFB Database, either entirely or partly, is not allowed for commercial use.
4. **Publication requirements:** In no case should the images be used in a way that could possibly cause embarrassment or mental anguish to all the subjects.
5. **Acknowledgement to CASIA:** In all documents and papers that report experimental results based on the database, a citation to "Stan Z. Li, Zhen Lei, Meng Ao, The HFB Face Database for Heterogeneous Face Biometrics Research. In *6th IEEE Workshop on Object Tracking and Classification Beyond and in the Visible Spectrum (OTCBVS, in conjunction with CVPR 2009)*. In *Proceedings of IAPR/IEEE International Conference on Biometrics, (ICB-2007)*. Seoul, Korea, August 2007." should be added to the references.
6. **Publication to CASIA:** Authors of all reports and papers that use the CASIA HFB Database are kindly requested to send copies of these publications to cbsr-request@authenmetric.com for documentation and progress review.
7. **Indemnification:** All persons using the database agree to indemnify, defend and hold harmless CASIA and its officers, employees and agents, individually and collectively, from any and all losses, expenses, damages. If any, users shall pay all damages, claims, judgments or expenses caused by misuse of CASIA HFB database.

Note: **Signatory must have the legal authority to sign licensing agreements on behalf of the Licensee with CASIA.** Licensee's legal staff should review the terms and conditions of this agreement and execute it. Agreements signed by individuals without this authority are not valid and will be discarded.
