Introduction

CASIA-SURF HiFiMask DATABASE is used for scientific research on face anti-spoofing attack detection. It should be authorized by the Institute of Automation, Chinese Academy of Sciences (CASIA) if anyone or any group is allowed to use this database free of charge.

Rules

1.Redistribution: Without prior approval from CASIA, the CASIA-SURF HiFiMask database, either entirely or partly, should not be further distributed, published, copied, or disseminated in any way or form, no matter for profitable use or not, including further distribution to a different department or organization in the same system.

2.Modification: Without prior approval from CASIA, the CASIA-SURF HiFiMask database, either entirely or partly, is not allowed to be modified.

3.Commercial Use: Without prior approval from CASIA, the CASIA-SURF HiFiMask database either entirely or partly, is not allowed for commercial use.

4.Publication requirements: In no case should the videos be used in a way that could possibly cause embarrassment or mental anguish to all the subjects.
